FELONY COMPLAINT

I, the undersigned, say, on information and belief, that in the County of San Mateo, State of California:

COUNT 1: PC460(a) (Felony)

On or about January 6, 2026, in the County of San Mateo, State of California, the crime of First Degree Burglary, Person Present in violation of PC460(a), a Felony, was committed in that ARTHUR JR GUTIERREZ AND JAMES WILLIAM JACOBS AND ANGELMIKE VA REGALADO did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by Patrick Michael Calleja, Shawna Marie McAlister, Floyd Cooper, George Marcos Georgiou and Silvino Angel Jr Manzano, with the intent to commit any felony. NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c). It is further alleged that the above offense is a violent felony within the meaning of Penal Code 667.5(c) in that another person, other than an accomplice, was present in the residence during the commission of the above offense.

ENHANCEMENT 1

PC12022.5(a): Special Allegation-Use Of Firearm

It is further alleged as to Count 1 that in the commission and attempted commission of the above offense, the said defendants, ANGELMIKE VA REGALADO AND ARTHUR JR GUTIERREZ, personally used a firearm(s) within the meaning of Penal Code section 12022.5(a) also causing the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8) and a violent felony within the meaning of Penal Code section 667.5(c)(8).

ENHANCEMENT 2

PC12022(a)(1): Special Allegation-Armed With Firearm

It is further alleged as to Count 1 that in the commission and attempted commission of the above offense as to defendants ANGELMIKE VA REGALADO AND ARTHUR JR GUTIERREZ, a

1 principal in said offense was armed with a firearm(s), said arming not being an element of the above
2 offense, within the meaning of Penal Code section 12022(a)(1).

4 **ENHANCEMENT 3**

5 It is further alleged pursuant to Penal Code 12022(d) as to Count 1 that a principal was armed with a
6 firearm during the commission of the above offense and that defendant, JAMES WILLIAM
7 JACOBS, not personally armed, knew that a principal was personally armed with a firearm.

8 **COUNT 2: PC245(b) (Felony)**

9 On or about January 6, 2026, in the County of San Mateo, State of California, the crime of Assault
10 with Semi-Automatic Firearm in violation of PC245(b), a Felony, was committed in that ARTHUR
11 JR GUTIERREZ AND JAMES WILLIAM JACOBS AND ANGELMIKE VA REGALADO did
12 willfully and unlawfully commit an assault on Silvino Angel Jr Manzano with a semi-automatic
13 firearm

15 **ENHANCEMENT 1**

16 **PC12022.5(a): Special Allegation-Use Of Firearm**

17 It is further alleged as to Count 2 that in the commission and attempted commission of the above
18 offense, the said defendants, ANGELMIKE VA REGALADO AND ARTHUR JR GUTIERREZ,
19 personally used a firearm(s) within the meaning of Penal Code section 12022.5(a) also causing the
20 above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8) and a violent
21 felony within the meaning of Penal Code section 667.5(c)(8).

22 **COUNT 3: PC245(b) (Felony)**

23 On or about January 6, 2026, in the County of San Mateo, State of California, the crime of Assault
24 with Semi-Automatic Firearm in violation of PC245(b), a Felony, was committed in that ARTHUR

JR GUTIERREZ AND JAMES WILLIAM JACOBS AND ANGELMIKE VA REGALADO did willfully and unlawfully commit an assault on Patrick Michael Calleja with a semi-automatic firearm

ENHANCEMENT 1

It is further alleged as to Count 3 that in the commission and attempted commission of the above offense, the said defendants, ANGELMIKE VA REGALADO AND ARTHUR JR GUTIERREZ, personally used a firearm(s) within the meaning of Penal Code section 12022.5(a) also causing the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8) and a violent felony within the meaning of Penal Code section 667.5(c)(8).

COUNT 4: PC207(a) (Felony)

On or about January 6, 2026, in the County of San Mateo, State of California, the crime of Kidnapping in violation of PC207(a), a Felony, was committed in that ARTHUR JR GUTIERREZ AND JAMES WILLIAM JACOBS AND ANGELMIKE VA REGALADO did unlawfully, forcibly and by instilling fear, steal, take, hold, detain and arrest Patrick Michael Calleja in San Mateo County, California, and did take the said Patrick Michael Calleja into another country, state, county and another part of San Mateo County. NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c). NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c). 20 12022.5(a) also causing the above offense to become a serious felony pursuant to Penal Code section

20 GUTIERREZ AND JAMES WILLIAM JACOBS AND ANGELMIKE VA REGALADO did
21 unlawfully violate the personal liberty of Floyd Cooper, said violation being effected by violence,
22 menace, fraud, and deceit.

5 On or about January 6, 2026, in the County of San Mateo, State of California, the crime of Possession
6 Of Firearm By A Felon - One Prior in violation of PC29800(a)(1), a Felony, was committed in that
7 ANGELMIKE VA REGALADO did unlawfully own, possess, purchase, receive, and have custody
8 and control of a firearm, to wit, HANDGUN, the said defendant, ANGELMIKE VA REGALADO
9 having theretofore been duly and legally convicted of a felony or felonies, to wit:

10 1) PC 422, felony on May 13, 2005 in Fresno County Superior Court Docket Number F059022369

11 2) HS 11377, felony on September 1, 2009 in Fresno County Superior Court Docket Number
12 F07902347

13 3) PC 273.5, felony on January 28, 2015 in Fresno County Superior Court Docket Number
14 F14911380

15 COUNT 11: PC30305(a)(1) (Felony)

16 On or about January 6, 2026, in the County of San Mateo, State of California, the crime of Possession
17 Of Ammunition in violation of PC30305(a)(1), a Felony, was committed in that ANGELMIKE VA
18 REGALADO did unlawfully own, possess and have under control ammunition and reloaded
19 ammunition. It is further alleged that the defendant is prohibited from owning or possessing a
20 firearm pursuant to Chapter 2 and 3 of Division 9 and sections 8100 and 8103 of the Welfare and
21 Institutions Code, having been previously convicted of the following offense(s):

22 1) PC 422, felony on May 13, 2005 in Fresno County Superior Court Docket Number F059022369

23 2) HS 11377, felony on September 1, 2009 in Fresno County Superior Court Docket Number
24 F07902347

1 3) PC 273.5, felony on January 28, 2015 in Fresno County Superior Court Docket Number
2 F14911380

3 NOTICE: Conviction of any of the above felony counts requires relinquishment of firearms,
4 ammunition and ammunition feeding devices.

5
6 Pursuant to Penal Code Section 1054.5(b), the People are hereby informally requesting that
7 defendant(s) and his or her attorney provide to the People the discovery required by Penal Code
8 Section 1054.3. This is a continuing request pursuant to the provisions of Penal Code Section 1054.7.

9 I declare under penalty of perjury that the foregoing is true and correct except for those things
10 stated on information and belief and those I believe to be true.
